Call to Order: Chairman Ingram convened at 7:10PM

Councilwoman Hughes and Pleasant Run extension project:

- Shared information about the Pleasant Run project and opened for Elizebeth who oversees capital improvement and roads in Desoto
- Elizebeth provided overview and updates
 - Project has been in the works since 2018
 - Since then have been waiting on property acquisition and obtaining remaining properties with only one more contingent
 - Once contingent property is resolved, At&t, and Oncore utilities will relocate (6 month project)
 - However, all is contingent on last remaining property
 - She provided visual layout and documentation and landscaping sheets which was passed out to members attending
- Chair then reinforced the importance of this project
- Elizebeth mentioned that if you have a recommendation, to send the proposal to HOA and chair will send additional requests to development director
- Need to come up with an agreed upon price to supplement what is lost in landscaping, electrical, irrigation and water estimated at \$75K back to HOA
- Also brought up the dangers of the exit and entrance on Cockrill Hill due to visibility of the hill on the south side of the entrance
- Elizebeth stated there is an online video for all propositions, however most of the propositions were to true up compliance with the state mandates
- Elizabeth then passed out the City of Desoto Comprehensive Plan update to those in attendance at HOA meeting
 - Desoto is going to grow by 30,000 by 2045
 - o They are wanting community feedback on what is needed
 - Land Use residents are going outside of Desoto for any entertainment
 - Transportation road maintenance and public transportation



- Housing not enough senior housing, additional workforce housing and multifamily housing
- Employment Growth

Chair:

- Jesse then asked each of the board members to introduce themselves, their role and background
- · Jesse then asked inviduals who attended the meeting

Treasurer:

- Utilities, Landscaping, water bill, fees for the website makeup total costs
- \$3,600 for Insurance is a heavy line item and working to find additional decreases in cost
- \$16,000 in past due HOA fees this will help our cash flow if reconciled
- Collection company will be potentially employed to assist
- The board will put budget proposals together and propose new budget
 - Cost of Website Management
 - Cost of end of year community event potentially pulled separate of HOA funds
 - Cost of HOA management

Social Chair:

- Gave overview of event planning
- The plan is to have one event towards the end of year near holiday season but more is to come here

Technology:

- Sam provided update on SSL encryption for website being enabled
- Ross McBride mentioned Royce West was involved with ATT and Spectrum –
 great for inquiring about the Fiber options Sam will meet with Royce
- New board members were added to website
- SSL encryption was added to website address
- Talked about the website news section and bringing it up on that news section of the website
- Explained the capabilities of the IONOS hosting platform and the possibility of hiring a website designer to assist in managing/rebuilding the website however would need to discuss budget for this
- Discussed the potential for updating contact information to then send out a quarterly newsletter

New Business

- Section 202 of property code mandates the solar panels are allowed, HOA cannot control this, however looking for curtesy notification
- Everything is increasing from a cost perspective, and we need to recoup what we can with the community. This was discussed with the community members in attendance.



- Jesse mentioned finding a new management company. The community members in attendance mentioned reccomended using talents in the community to help out HOA first
- Section 209: Ross McBride, brought up the fact that 2 votes were removed because of not paying dues and it will be looked into
